# WELCOME BACK COLLEAGUE

As another academic year begins, we at CUASA hope it will be a great year for you, your students and your research/scholarly activities.

Certainly it promises to be an eventful year.

# PROVINCIAL ELECTION

On September 10th, only two days after the beginning of the Fall term, Ontario voters will elect a new government. Through the Ontario Confederation of University Faculty Associations (OCUFA), our provincial federation, we have reminded all candidates and all parties that, despite somewhat better treatment by the previous Liberal-NDP coalition, Ontario continues to rank well below most other provinces in its per student support for universities.

Says OCUFA President John Starkey in his letter to the candidates: "It will take almost a decade to simply redress the severe underfunding of the past dozen years" at the rate the Liberals are going. Before you cast your ballot you should know not only where your candidates stand on this issue but, more importantly, the position of their party.

# NEGOTIATIONS

We are in the final year of a three-year collective agreement. It expires April 30, 1988 and negotiations will begin no later than February 1, 1988. We hope that this round of bargaining will be conducted in a decisive and expeditious manner, unlike the prefious round.

We will be contacting each department to arrange a meeting before negotiations begin. It is your collective agreement. We want to know where it is serving you well and where it needs improvement. Already we are aware of a good deal of dissatisfaction in the areas of workload and teaching evaluations. Through the Joint Committee to Administer the Collective Agreement we have already raised these problems with the administration and are conducting research into both prior to negotiations. Also under consideration by the JCAA are reciprocal free tuition and electronic transfer of paycheques to the bank of your choice.

In this improved economic climate for post secondary education we are also determined to win back some of the erosion of academic staff salaries over a decade of government hostility to workers in general and to the post secondary education system in particular.

# CARLETON CHALLENGE FUND

The administration, in its most recent communication, says the challenge fund has already raised more than \$5 million of its \$15-million goal. This is good news. CUASA has high hopes for the campaign and the benefits it can bring to all involved at Carleton.
