PAY EQUITY FOR PROFESSIONAL LIBRARIANS

The employer and CUASA have agreed on a proposal to address pay equity for the sub-unit of professional librarians in our bargaining unit. The proposal calls for two phases.

Phase I would see the upper and lower limits of the salary rationalisation diagram (see page 288 of the collective agreement) move closer together. This will make 14 librarians 'automatic anomalies'. Their salaries - once the lower limit is raised - will fall below the lower limit and will be increased so that they fall within the revised parameters. These salary adjustments will be retroactive to January 1, 1990.

Phase II, the Salary Adjustment Commission will analyze in a detail the relationship of professional librarian salaries to the standard line in their diagram compared with the relationship of faculty salaries to the standard line in the faculty diagram. Phase II is expected to take some time. The Commission has a number of other items on its agenda, such as a study of female faculty salaries, market differentials, and individual requests for salary review.
