TRENT STRIKE SETTLED!

On March 25, 1991 the Trent University Faculty Association and the Trent Board of Governors settled the strike, with Martin Teplitsky appointed as mediator, had the two parties failed to settle finally the terms of the collective agreement.

The following day the parties reached agreement on all outstanding issues. Their agreement, which has a term of three years, provides a formula for narrowing the gap between salaries paid Trent Faculty and the average salary of faculty in other Ontario universities.

The parties also agreed to comprehensive principles to ensure completion of the academic year and to alleviate prejudice to students. The commitment of both the faculty and the administration to achieve this goal did not waiver and was not a source of dispute between the parties.

Of necessity, considerable additional work by the faculty and librarians will be necessary and the parties have agreed that \$1,200 is appropriate compensation for the additional work which includes an extension of the teaching year.

Finally, the parties were able to utilize some of the surplus of the Pension Plan to improve its benefits.

UNIVERSITY GOVERNANCE

CAUT has arranged with the Canadian Political Science Association for there to be a joint session with CAUT at the Learned Societies' meeting at Queen's on university governance. This will be chaired by Prof. Dan Soberman of the Faculty of Law at Queen's University. There will be a four-person panel. Two members of the CAUT's Independent Study Group will be participants. The other two, chosen by CPSA, are Prof. Ron Watts, former Principal of Queen's University, and Prof. David Cameron of Dalhousie University.

The **deadline** to submit receipts for the **Professional Development Allowance** is **April 30, 1991**. The employer has circulated a Professional Development Reimbursement form to all members. If you require another form contact your Dean. You may claim the \$500 as soon as you have spent it, by submitting the original receipts to your Dean (or equivalent). Because the collective agreement expires April 30, 1991, the carry over clause also terminates. However, those wishing to purchase a large item in excess of their allowance may claim their full allowance this contract year on the basis of submission of the original invoice and the re-submit a copy of the invoice after May 1, 1991 for reimbursement out of the allowance negotiated for 91-92. These funds must be spent in their entirety by **April 30, 1991**.
