## BENEFITS PREMIUMS TO DECREASE

The existing benefits will remain the same but premiums paid by members of CUASA will be reduced as follows:

Long Term Disability Insurance	-	10% reduction
Basic Group Life Insurance	-	no change
Optional Group Life Insurance	-	10% reduction

As Long Term Disability and Optional Life premiums are fully paid by CUASA members the premium rate reductions will, effective July 1, result in a saving to all staff covered by these plans.

These premium reductions will be reflected in the end of July salary cheques.


